- MONEY ORDER OR CASHIER CHECK FOR US\$ 60, PAYABLE TO: CONSULATE OF VENEZUELA.
- PRE-PAID, SELF ADDRESSED ENVELOPE (PRIORITY MAIL, EXPRESS MAIL, DHL, ETC). (PLEASE DO NOT USE FEDEX SERVICES).

- NON US CITIZENS, PLEASE SEND COPY OF THE GREEN CARD (BOTH SIDES).
- WITHOUT EXCEPTIONS, APPLICATIONS WITH INCOMPLETE REQUIREMENTS WILL BE RETURNED.
- IT TAKES 72 HOURS TO PROCESS THE VISA.
